# CH Karnchang (CK TB)

## Another Quarter Of Solid Core Revenue; BUY

- Maintain BUY and SOP-based THB24.50 TP, 15% upside and c.2% yield. We expect CH Karnchang to continue to benefit from stronger construction revenue in 4Q23, and this solid momentum should continue in FY24. A potential win of a new infrastructure project expected to be opened for bidding this year would also be an upside for its future performance.
- 4Q23 earnings to rely on its core businesses and affiliates' performances. We expect 4Q23 net profit of THB181m (+61% YoY, -72% QoQ). Similar to the three previous quarters' core revenue of >THB9bn, 4Q23 core revenue should remain high at THB9.3bn (+133% YoY, +3.5% QoQ) as the Luang Phrabang hydropower project in Laos should provide a major boost to 4Q23 construction revenue. The on-track construction progress of other major projects including the Purple Line Mass Rapid Transit (MRT) extension, double-tracking of the Den Chai-Chiang Rai-Chiang Khong railway route, and Bang Ban-Bang Sai flood drainage canal should also provide a solid base for construction revenue. 4Q23 GPM may decline slightly QoQ to 7.7% due to the higher revenue proportion of the Luang Phrabang project. Without the effect of scale economies, 4Q23 SG&A expenses should increase, based on higher bonus payments for the company and its subsidiaries. In addition to strong construction revenue, profit sharing from both its major associated companies will be another growth highlight in 4Q23, based on a surge in Blue Line MRT ridership and higher electricity production for two major hydropower projects in Laos.
- **Based on our 4Q23 earnings forecasts**, FY23 net profit should grow strongly by 38% YoY to THB1.53bn from a higher base of core revenue throughout the year (>THB9bn per quarter in FY23 vs >THB4bn per quarter in FY22) and stronger performances of its associates, although there were smaller gains from selling investments in FY23.
- Near-term prospects for new infrastructure projects. In Jan 2024, there was still an absence of new key infrastructure bids announced by the Government. However, it is likely that the Government will start a new bidding cycle from 2Q24 onwards. Based on recent developments from agencies under the Ministry of Transport, this upcoming cycle should begin with the Chalong Rat expressway extension (Chatuchot Outer Ring Road) that could be launched for bidding by as early as April. The new double-track railway route (Khon Kaen Nong Khai) and Red-Line MRT extensions are potential upcoming projects by mid-2024.
- ESG. Our ESG score for CK remains at 2.6 against the country median of 3.2. Accordingly, we have a 12% ESG discount baked into our TP. We maintain our SOP-based TP at THB24.50.



#### Trend analysis


Only Scope 2 emissions data has been released. Based on the electricity it consumed in FY22, greenhouse gas (GHG) emissions (Scope 2) resulting from energy consumption from the purchase of electricity within the company stood at 1,654.8 tonnes of CO2e during the year - up 1.6% YoY but 5.1% lower than FY20 levels.

## Latest ESG-Related Developments

- For GHG emissions, the company has managed its business activities in line with the goals of the Paris Agreement.
- Its move towards having net zero carbon emissions by 2050 may be executed via the sustainable use of natural resources, energy, and water (based on eco-efficiency and circular economy principles); reducing emissions; improving waste management; disclosing GHG emissions; appraising climate change risks along with the impact on related businesses; and setting and maintaining guidelines for managing risks caused by climate change.
- In FY22, CK was considered by Thaipat Institute to receive the ESG 100 award for a seventh consecutive year.
- In FY23, the company aims to report complete carbon emissions at all project offices as a guideline to reduce carbon emissions effectively in the following years. This is to promote the transition to a carbon-neutral entity.
